Effective February 29, 2016, processors of certified "organic" and "100 percent organic" fluid milk products may apply for an organic assessment exemption for those products.

^{3/} The Class I extended shelf life (ESL) adjustment for all ESL products is equal to the average of the advanced Class III and Class IV skim pricing factors plus a 24-month rolling average adjuster less the higher of the advanced Class III and Class IV skim pricing factors.
